

Western Pension & Benefits Council Orange County Chapter Statement of Privacy

Western Pension & Benefits Council Orange County Chapter (WP&BC Orange County) is committed to protecting your privacy. This Statement of Privacy applies to WP&BC Orange County web site and governs data collection and usage at all WP&BC Orange County sites and services; it does not apply to other online or offline sites, products or services. Please read the WP&BC Orange County Statement of Privacy. WP&BC Orange County is a general audience web site, intended for users of all ages. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.

Collection of your Personal Information

As an E-commerce web site and as a membership organization, WP&BC Orange County collects personal information, such as your e-mail address, name, home or work address or telephone number. WP&BC Orange County does not collect any information about your computer hardware and software.

WP&BC Orange County encourages you to review the privacy statements of web sites you choose to link to from WP&BC Orange County so that you can understand how those web sites collect, use and share your information. We are not responsible for the privacy statements or other content on web sites outside of the WP&BC Orange County web site.

Use of your Personal Information

WP&BC Orange County collects and uses your personal information to process transactions for membership dues and meeting fees as requested. It is possible that WP&BC Orange County may also use personal information to inform you of other products or services available from WP&BC Orange County and its affiliates. WP&BC Orange County may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

WP&BC Orange County maintains membership data and records in a variety of ways, including offline databases and an online roster. Membership data includes telephone numbers, email addresses and physical mailing addresses. When you become a member of WP&BC Orange County, this contact information will be published in the online roster. The online roster is available to all members of all chapters of the Western Pension & Benefits Council (WP&BC.)

WP&BC Orange County does not sell, rent or lease its customer lists to third parties. WP&BC Orange County may, from time to time, contact you on behalf of other WP&BC chapters about a particular offering that may be of interest to you. In those cases, your personal information is not transferred to the third party.

WP&BC Orange County will provide your contact information (name, email address, physical mailing address) to the American Society of Pension Professionals & Actuaries (ASPPA) for the purpose of informing you about the annual Western Benefits Council, jointly sponsored by WP&BC and ASPPA each summer. ASPPA is required to maintain the confidentiality of your information and is prohibited from using that information for any other purpose.

WP&BC Orange County does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

WP&BC Orange County may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on WP&BC Orange County or the site; (b) protect and defend the rights or property of WP&BC Orange County, including its web site; or (c) act under exigent circumstances to protect the personal safety of users of WP&BC Orange County or the public.

Personal information collected on this site may be stored and processed in the United States or any other country in which WP&BC Orange County or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country. WP&BC Orange County abides by the safe harbor framework as set forth by the U.S. Department of Commerce regarding the collection, use, and retention of data from the European Union.

Security of your Personal Information

WP&BC Orange County is committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. For example, we store the personal information you provide on computer systems with limited access that are located in controlled facilities. When we transmit highly confidential information (such as a credit card number) over the Internet, we use a secure payment gateway so your information is protected.

Changes to this Statement

WP&BC Orange County will occasionally update this Statement of Privacy to reflect company and customer feedback. If there are material changes to this Statement or in how WP&BC Orange County will use your personal information, WP&BC Orange County will prominently post such changes prior to implementing the change. WP&BC Orange County encourages you to periodically review this Statement to be informed of how WP&BC Orange County is protecting your information.
